

25-YEAR TRANSFERABLE LIMITED WARRANTY



AtticFoil® Radiant Barrier is a reflective insulation guaranteed against delaminating and defects in material and workmanship for 25 years from date of purchase.

LIMITED WARRANTY. AtticFoil® Radiant Barrier Supply, LLC (“AtticFoil”) warrants the original owner and all subsequent owners of the building (each a “Product Owner”) in which AtticFoil® Radiant Barrier Product intended for use within the attic either on the underside of roof rafters, or laid out over attic insulation as is originally installed, is free from defects in material and manufacturing. When used for its original intended purpose, properly maintained and the installation of the product is performed in compliance with instructions, and if the product is not damaged, misused, or mishandled after delivery by AtticFoil®:

- (a) When delivered to the Product Owner, the Product will comply with AtticFoil’s published specifications for the Product.
- (b) For a period of twenty five (25) years after purchase date, the Product will serve as a radiant barrier.
- (c) For a period of twenty five (25) years after delivery to the Product Owner by AtticFoil®, the Product will be free from defects in material and workmanship under normal use and service that materially impair the Product’s ability to reduce heat transfer by radiation.
- (d) For a period of twenty five (25) years after delivery to the Product Owner by AtticFoil®, the Product will remain free of areas of separation of the foil greater than 3% of surface area, which result in material reduction of the Product’s ability to reduce solar heat gain.

ATTICFOIL DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH REGARD TO THE PRODUCT, EXCEPT WHERE PRODUCT PURCHASE IS SUBJECT TO CONSUMER WARRANTY LAW.

No employee or agent of AtticFoil® has the authority to promise or give any warranty different from, or in addition to, the express warranties set forth herein, and has no authority to waive any of the exclusions from warranties set forth herein. If you purchase and use the Product, in a state that does not allow certain warranties to be disclaimed, then such warranties are limited to the shortest period as required or permitted under the law of your state.

EXCLUSIONS FROM WARRANTY. This warranty does not apply to any damage; the following criteria may be considered damage:

- One inch wide or more of foil de-lamination on the edges for more than 15 feet of the roll.
- Large areas (more than one square foot) of delaminated foil.
- Improper installation, misuse, improper maintenance of, or changes, modifications or alterations to the Product.
- Severe weather conditions, lightning, earthquakes, floods, hurricanes, tornados, storms, or other acts of God.
- Repair, reconstruction, or alteration to the building structure after the original installation of the product.
